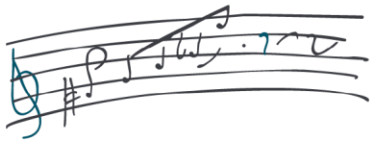

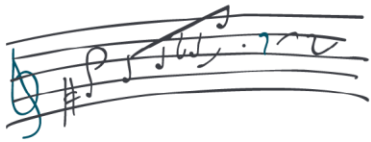
II. COMMITMENT OF THE THREE PARTIES
